ALEPPO SHRINE DIRECT PAYMENT PROGRAM

For payment of your Aleppo Shrine dues and activities

We are again pleased to offer you an optional service—the Direct Payment Plan.

Now you can have your desired payments deducted automatically from your checking or savings account.

The Direct payment option may be an advantage to you because:

- It is a safe, easy, and convenient way to pay your Shrine dues.
- It spreads the fees out over the year so it is not due at one time.
- It is easy to sign up for and easy to cancel.
- There is no charge to you for this service.

Here's how the Direct Payment Plan works:

- You authorize regularly scheduled payments to be made from your checking or savings account, then, just sit back and relax.
- Your payments will be made automatically on the specified day, and proof of payment will appear on your statement.
- The authority you give to charge your account will remain in effect until you notify us in writing to terminate the authorization. If the amount of your payment would ever change, we will notify you at least 10 days before the payment date.
- The Direct Payment Plan is dependable, flexible, convenient and easy. To take advantage of this service, complete the authorization form on the right and return it to us.

All you need to do is:

- 1) Mark the box before type of account to indicate whether your payment will be deducted from your checking or savings account.
- 2) Fill in your name, financial institution name and location, and date.
- 3) Attach a voided check for verification of all financial institution information. If you are unable to attach the voided check, please fill in your account number and routing number.
